Cluster 1: Development, Economy and Environment

- 1** Resource 1 shows areas of estimated iron ore reserves. Resource 2 shows the landscape of an area before and after mining took place in Roşia Montană, Romania. Resource 3 shows the spatial structure of vehicle production, exports and sales by Toyota, a transnational company (TNC). Resource 4 is a fact file on Brazil.
- (a) Using an example for each, explain what is meant by renewable and non-renewable resources. [4]
- (b) Describe the global distribution of estimated iron ore reserves shown in Resource 1. [5]
- (c) With reference to Resource 2, suggest how mining may affect the environment. [4]
- (d) Explain why mineral extraction, such as iron ore mining, is dominated by large Transnational Companies (TNCs). [6]
- (e) With reference to Resource 3, explain how Toyota's spatial structure shows the interconnectedness of the world. [6]
- (f) Cite data from Resources 1 and 4 to explain why Toyota vehicle production in Brazil continued in 2014. [5]

Cluster 2: Tropical Environments

- 2 Resource 5 shows the climate graph of Ho Chi Minh, Vietnam. Resource 6A is a schematic diagram of drainage basin systems in Tropical Savannah climate zone during the wet season. Resource 6B is a schematic diagram of drainage basin systems in Tropical Savannah climate zone during the dry season. Resource 7 shows the land cover of upstream Dong Nai River Basin, Vietnam in 1973 and 2014. Resource 8 is a map of Pacific Ocean showing the location of Vietnam within the tropical Pacific.
- (a) Cite data from Resource 5 to describe the temperature and rainfall characteristics of Ho Chi Minh, Vietnam. [4]
- (b) Describe components X and Y shown in Resource 6A. [4]
- (c) Describe the differences between the drainage basin systems during dry and wet seasons shown in Resources 6A and 6B respectively. [5]
- (d) Describe the changes in the land cover of upstream Dong Nai River Basin shown in Resource 7. [5]
- (e) With reference to Resource 7, explain how land cover changes may affect flows and stores in the Dong Nai River Basin. [6]
- (f) With reference to Resource 8, explain the rainfall patterns during the El Nino and La Nina phases in western Pacific countries such as Vietnam. [6]
